Stallion Service Contract for Cooled Semen

THIS AGREEMENT, made and entered into on the _____ day of _____, in the year _____, is between STORYTELLERFARMS, LLC and Mare Owner/Agent:

This document verifies that STORYTELLERFARMS, LLC agrees to furnish semen from the Stallion: **LESTER PATRON** - Registration # 51-00056-95, For the _____ breeding season beginning MARCH 1, _____ to SEPTEMBER 1, _____.

Subject to the following conditions:

1. The stud fee shall be \$1500.00. In addition, a \$ 300.00 one time non-refundable Booking / Stud fee is due upon receipt of signed breeding contract.
 - A. Mare owner is also responsible for estimated collection fees of \$275-\$375, plus a \$ _____ \$200 _____ refundable Equitainer deposit (if Applicable).
 - B. In addition to the stud fee, the Mare Owner will be responsible for all fees, due to STORYTELLERFARMS, LLC prior to semen shipments. (i.e. shipping, collection, and booking Fees)
 - C. If the cost of shipping semen to the mare exceeds the estimated amount, the Equitainer deposit will be applied to the outstanding balance. If the shipping cost is less than the estimated amount; the balance will be refunded along with the Equitainer deposit.
2. It is the responsibility of the Mare Owner/Agent to insure that the DELIVERY CERTIFICATE enclosed with each semen shipment, is properly filled out by the attending veterinarian and returned to STORYTELLERFARMS, LLC after each insemination.
 - A. MARE IDENTIFICATION PASSPORT must be returned to STORYTELLERFARMS,LLC signed by a licensed veterinarian after the mare is examined 50 to 55 days IN FOAL OR NOT IN FOAL.

3. If the mare is bred with **FROZEN SEMEN:**

Check for Availability of Frozen Semen.

- A. STORYTELLERFARMS, LLC will ship a total of six straws of FROZEN SEMEN per Stud fee. STORYTELLERFARMS, LLC will ship enough semen for an average of three heat cycles, at two straws per cycle.
- B. If the mare fails to conceive after using the original six straws, individual straws are available to the Mare Owner/Agent at the cost of \$ _____ per straw.

4. LIVE FOAL GUARANTEE:

- A. Should the MARE ABORT or the FOAL FAIL TO STAND AND NURSE AT 24 HOURS, it is the responsibility of the Mare Owner/Agent to notify STORYTELLERFARMS, LLC in writing by a licensed veterinarian within 10 days of the event.
- B. STORYTELLERFARMS, LLC agrees to rebreed the mare the following year. Booking and handling fees, approximate shipping, lab fees, and Equitainer deposit will be the same as stated above.
- C. If **FROZEN SEMEN** is used: should the MARE ABORT or the FOAL FAIL TO STAND AND NURSE AT 24 HOURS, the Stallion Owner/Agent STORYTELLERFARMS, LLC, agrees to send six additional straws for the following breeding season. The Mare Owner/Agent is responsible for booking/handling fees and shipping costs. (**Check Availability of Frozen**)

5. If after breeding the mare through three heat cycles, the mare fails to conceive, STORYTELLERFARMS, LLC offers the following options:

- A. The Mare Owner/Agent may have the reproductive status of the mare evaluated and continue to breed the mare in the same year or the following season.
- B. Should the mare die or become unfit for breeding, STORYTELLERFARMS, LLC may accept a substitute mare that meets requirements for breeding (i.e. Conformation, Registration, Etc.)

6. Mare Owner/Agent shall assume all responsibility for the condition of the mare and bear all the risk of loss or damage to the mare whether by death, disease, injury, infection, accident, sickness or otherwise and by any cause whatsoever, and therefore agrees to hold the Stallion Owner or STORYTELLERFARMS, LLC or any person employed or associated with the Stallion Owner and/or Agent and STORYTELLERFARMS, LLC harmless for any and all damages associated there with.

7. This contract may not be assigned or transferred without the written Consent of STORYTELLERFARMS, LLC.

8. This agreement shall be construed and enforced under the laws of the State of California. Jurisdiction for any arbitration or court Proceedings shall be in the County of Los Angeles, California.
